Introduction

Supplemental Assignments

Supplement for Standard CCSS.ELA-Literacy.RH.11-12.3

Evaluate various explanations for actions or events and determine which explanation best accords with textual evidence, acknowledging where the text leaves matters uncertain.

This addition is part of the **Lesson 4** in the Psychology curriculum. The assignment below is to be added after the existing assignment #2.

Supplemental Assignment

Maslow's study provides various explanations for human actions and behavior. It is important to be able to pinpoint where a writer chooses to further strengthen his or her key points and where they do not, and why. Keeping that in mind, which explanations are backed up by textual evidence (examples, sources), and which are simply stated without the use of a specific example? How does this support or lack or support affect your opinion?

Integrate and evaluate multiple sources of information presented in diverse formats and media (e.g., visually, quantitatively, as well as in words) in order to address a question or solve a problem.

Supplemental Assignment

After viewing "I Never Promised You a Rose Garden" and an old Woody Allen film, and reviewing the reading for this lesson, how would you change the way you interpreted or solved one of the Id/Ego/Super Ego conflicts you addressed in assignment #1, had you known all of this information first?

Analyze in detail how a complex primary source is structured, including how key sentences, paragraphs, and larger portions of the text contribute to the whole.

Supplemental Assignment

Each personal example in this lesson is a primary source, meaning that each are firsthand accounts of experiences each individual had. Analyze how these accounts are structured differently than the text in which they appear, keeping in mind the sentence and writing structure, and how these sections contribute to the text as a whole.
